# WWALS Watershed Coalition Annual Report 2019-2020

For review and approval at the July 12, 2020, WWALS Annual Member Meeting

#### 1 Overview

WWALS Vision: A healthy watershed with clean, swimmable, fishable, drinkable water.

**WWALS Mission:** WWALS Watershed Coalition advocates for conservation and stewardship of the Withlacoochee, Willacoochee, Alapaha, Little, and Suwannee River watersheds in south Georgia and north Florida through education, awareness, environmental monitoring, and citizen activities.

WWALS Watershed Coalition had many successes in its seventh year. We have much more earned media exposure on television and newspapers. We initiated a second paddle race, the Boomerang, in the fall and continued building on our annual spring event of the Big Little Paddle Race at Reed Bingham State Park, in conjunction with Friends of Reed Bingham (FORB) We changed our non-profit platform with Georgia Gives from clickandpledge.com to mightycause.com. Our information with networkforgood.org and guidestard.org is current and allows donors to verify our non-profit status. Our total income was just under \$20,000 and our total expenditures were \$23,443.38.

The group held four full board meetings (July, October, January, April). Many public meetings and events were held throughout the watershed. There were twenty four scheduled outings, including paddles, trash pick-ups, some awareness events, along with impromptu scouting trips and investigations.

WWALS published a monthly newsletter and numerous blog posts, wrote letters and press releases, spoke to several community groups at their regularly scheduled meetings, and had a booth at many community festival events in an effort to raise awareness about the watershed. The enviroscape that we received last year has been an excellent teaching tool at the festival booth.

### 3. 2019-2020 Goals

The goals continue to reflect work done in 2016 to guide the organization.

WWALS <u>Goals adopted 2 October 2016</u> are overarching items which help us achieve our vision and mission.

- 1. Education of general public about conservation and stewardship of WWALS watershed.
  - a. Outreach to youth, teachers, community leaders through outings, art contests, etc.
  - b. One time per year hold workshop for educators and adults
  - c. One time per year hold workshop for youth
  - d. One time per year art project open to public, private, and home schoolers.
- 2. Act as a knowledge resource about physical, biological and natural resources to, and about, our community.
  - a. Maintain an Inventory of resources of health and science (geology, biology, hydrology) which support our educational activities.
  - b. The inventory will include native and invasive species information, maps, information about existing organizations (NRCS, University Extensions, Water Management Districts, etc)
  - c. Record what we see now and continue to record to see if things change (photos, water quality)
  - d. Develop a systematic way to store this inventory of information.
  - e. Commission WWALS Science Committee Tom Potter to chair
- 3. Engage with local agencies on routine water quality testing
  - a. Find out what is happening now
  - b. Identify missing sampling (stormwater, others?)
  - c. Work with farm agencies (FSA, Farm Bureau, NRCS, Extension Offices) to learn what they do and present what we do and figure out how we can work together.
- 4. Develop and maintain documentation relevant to our watershed
  - a. Maps, water trails, brochures, photos, blog
  - b. (this somewhat overlaps with #2, however we develop documentation that is specific to WWALS projects, and views which will then be stored used by #2.)
- 5. Identify and address threats to the WWALS Watershed
- 6. Engage our community in outdoor activities. outings, water trails, fishing tournaments, geocaching, hiking, cleanups, etc.
  - a. Clean ups are stewardship in action.
- 7. Raise money to fund organization on an ongoing basis
  - a. develop a fundraising plan
  - b. finalize RIVERKEEPER® application (completed 2016; license signed December 2016)
  - c. approve budget

# 4. Financial Report by Treasurer

WWALS realigned its fiscal year from July to June to January to December. This will be the last report on a July to June cycle.

The beginning balance in all accounts on July 1, 2019 was \$13,786.11. The ending balance in all accounts as of June 30, 2020 was \$16,885.89. Our income still came primarily from membership and fundraisers. We again increased the amount paid to the staff position of Suwannee RIVERKEEPER®, but still do not pay a living wage. A variety of general bills and expenses were paid including Georgia and Florida corporate fees, liability insurance, Directors and Officers Insurance, water quality testing supplies purchases, website renewal, office supplies and postage, festival booths. We considered renting office space but that COVID-19 interrupted our plans. We applied for, and received, a Paycheck Protection Program loan for \$2083.00. Our total expenditures were \$26,882.28. We operated at a surplus of \$3,099.78. We continue to need to figure out a sustainable income stream.

The Big Little River Paddle Event scheduled for April, was postponed because of COVID-19. We had some successful on-line fundraisers around Earth Day in April and GeorgiaGivesNow in early May. The WWALS Boomerang paddle race in the fall, coordinated by board member Bobby McKenzie raised approximately \$500.00.

We are listed at GuideStar and fundraise on-line through gagives.org, Facebook, and others.

We continue using EventBrite to sell tickets as it streamlines the issuance of receipts and tickets and the fee is passed to the ticket buyer rather than being paid by WWALS.

Attached to the Annual Report are the following: Statement of Activity for January 2019 - December 2019, Statement of Activity January 2020 - June 2020 (1/2 the current year). In fiscal year 2020 we are on track for our amended, smaller budget.

# 5. Meetings

### 5.1. Meetings and Events Organized by WWALS

The board held three in-person meetings (July, October, January) and one on-line meeting (April) due to COVID-19. There were many committee meetings during the year both in-person, by teleconference and on-line video conferences. The committees meet on an as-needed basis or regularly and include Executive, Nominating, Advisory, Membership, Outings, Events, Public Relations, Water Trails, Songwriting, and Watershed Issues (formerly Pipeline). Committees are made up of WWALS board members and regular members who are interested in specific projects.

WWALS has been doing occasional on-line trivia events and photo identification quizzes to engage the membership during COVID-19.

#### 5.2. Community Outreach

WWALS gave numerous presentations and had booths at several festivals including attending Pride Festival, Harvest Festival, Honey Bee Festival, Rivers Alive CleanUp, Alapaha Station Celebration, and the Florida Springs Festival. Members attended the Lowndes County Bird Supper with Legislators in February. WWALS held two Georgia Adopt-A-Stream Water Quality Trainings that yielded several new volunteers. Suwannee Riverkeeper John S. Quarterman and board member Tom H. Johnson Jr. attended Capitol Conservation Day in Atlanta to talk with legislators about potential legislation. The same day they also attended the Lowndes County Bird Supper for the same reason. In between, John S. Quarterman visited the Georgia Environmental Protection Division about the Valdosta wastewater situation and agricultural nonpoint sources of bacterial waterway contamination. Later, in Valdosta, he gave a presentation to Georgia Power Employees about WWALS events and outings. We live streamed a paddle on Banks Lake and an Earth Day Clean-Up at Knights Ferry Boat Ramp on the Withlacoochee River. We held multiple on-line Trivia events hosted by Shelby Miller and had on-line quizzes dubbed "Within these WWALS" with flora and fauna photo identifications coordinated by Bret Wagenhorst.

Most WWALS festival booths and speaking engagements, past and planned, are listed in the Outings and Events web page http://wwals.net/events-2/outings-events/ and in the WWALS calendar, <a href="http://wwals.net/calendar/">http://wwals.net/events-2/outings-events/</a> and in the WWALS calendar, <a href="http://wwals.net/calendar/">http://wwals.net/calendar/</a>. COVID-19 completely eliminated festival events from March 10, 2020 onwards and has made in person meetings impractical. We are considering on-line webinars as a new outreach avenue.

The Public Relations Committee wrote and sent to members and friends a monthly newsletter. A reader favorite in each issue is the WWALS Biota, written by Bret Wagenhorst.

Suwannee Riverkeeper John S. Quarterman and several WWALS members have been interviewed by WALB and WCTV as well as being interviewed on Valdosta drive time radio with Steve Nichols, Charlie Walker and Scott James, plus Brian Blount based in Blackshear, GA. WWALS members were particularly active with the Florida twelve-county Rivers Task Force meetings.

## 6. Suwannee Riverkeeper Report, John S. Quarterman

 Waterkeeper Alliance approved formal addition of the Santa Fe River Basin as Suwannee Riverkeeper territory (we've been doing the work for years). The WWALS Board voted to insert "Santa Fe" into the WWALS Mission and logo. The WWALS Outings Committee scheduled and held several outings on the Santa Fe and Ichetucknee Rivers. We of course continue to work with Our Santa Fe River (OSFR) and other



- organizations in the Santa Fe River Basin, as we do with organizations throughout the Suwannee River Basin. For example, attended Bradford County, FL, BOCC meeting on a fifth Chemours titanium mine SE of Starke. BOCC voted 3:2 for it. - Suwannee River Water Management District (SRWMD).

  - f. Made WWALS yellow diamond Caution signs and posted them in the same locations.
  - g. Extracted data from Valdosta via open records requests, and Valdosta eventually commenced publishing its data on its own website, as well as testing three times a week on 40 river miles down to the state line plus Okapilco Creek.
  - h. Consolidated all of the above data, plus from SRWMD and FDOH; see <a href="https://www.net/issues/testing/">wwals.net/issues/testing/</a>
  - i. Valdosta says in Consent Order that it is doing DNA testing; nobody has seen it yet.
  - j. FDEP is doing human marker (e.g. sucralose) and DNA tests monthly; we have obtained those results.

Determined in conjunction with various parties, especially the WWALS Science Committee, that continuing waves of contamination after January 2020 starting at Knights Ferry Boat Ramp were probably coming down Okapilco Creek from cattle operations in Brooks County. Made contact with one or more possible sources. Discussed possible grants and fixes with GA DNR and SGRC; will apply this year.

# 7. Committee Reports

#### 7.1. Membership Committee Report, Gretchen Quarterman, Chair

In 2019 WWALS had 189 unique members and/or donors with an average donation of \$80.24. In 2020 so far we have 92 donors and/or members with an average of \$71.38. We are unable to account for the number of individuals that donate through Facebook as we cannot see who donated on the Network for Good website. We have 2407 likes on Facebook and 2553 Followers. These people are the most likely prospects to convert to members and donors.

Most memberships continue to be individual or family memberships, approximately 20% are supporting or sustaining members with a few giving at the \$500 and \$1000 levels. About 1/2 of our members renew each year. We continue to see a decline in renewals year after year, although we have new members join who keep our membership steady. We are significantly short of our goal of 100% renewals. We have stopped mailing paper renewals because of the cost of postage. We do e-mail renewal reminders. We must figure out some way to increase the percentage of renewals. Ideally, we would like to have all of our supporters become small monthly donors.

#### 7.2. Outings Committee Report, Bobby McKenzie, Chair

All WWALS Outings, past and planned, are listed in the Outings and Events web page <a href="http://wwals.net/events-2/outings-events/">http://wwals.net/events-2/outings-events/</a> and in the WWALS calendar, <a href="http://wwals.net/calendar/">http://wwals.net/calendar/</a>. There were several camping outings, many single day events and a monthly Full Moon paddles at Banks Lake near Lakeland, GA, to see the sun set and the moon rise. New in 2019 was a Solstice Light Parade, held at Banks Lake on the winter solstice. One particularly popular paddle this year was the "Valdosta Mayor's Paddle" on the Withlacoochee River in January 2020, with new Valdosta Mayor Scott James Matheson. All types of outings are well attended.

With Social Distancing changing the way we do outings for the foreseeable future, we have focused on out and back paddles and introduced a series of bike and paddles to avoid the need for shuttles. The full moon paddles have been very popular with June's paddle having 33 participants. Banks Lake Outdoors offering their free rentals for our Full Moon Paddles has been great. We are moving forward on getting ready for the Boomerang. Moody AFB Outdoor Rec has reached out and wants to join our outings.

#### 7.3. Trails Committee Report, Dan Phillips, Chair

Suwannee Riverkeeper and the Trails Committee designed and printed metal water trail informational signs and Dan Phillips installed them at the new Naylor Boat Ramp on the Alapaha River Water Trail, and at several locations on the Withlacoochee and Little River Water Trail. Both trails were considered completed by the Georgia River Network.





The <u>WWALS online maps</u> for both water trails, as well as for the Suwannee River Wilderness Trail, and a composite map of all public landings in the Suwannee River Basin, have all been updated with more landings and springs.

Z-fold brochures for both water trails await final funding for printing. See Grants Committee about a projected grant for printing brochures and more at-water signs plus road signs.

WWALS submitted grant proposals to several organizations, including Georgia Power Foundation, Georgia Department of Natural Resources Recreational Trails Program (RTP) Educational Grant, Georgia Outdoor Stewardship Program for a Troupville River Camp, and North Face Explore Fund. We are waiting on final paperwork for the RTP Educational Grant, which will pay for brochure printing, road signs, and kiosk signs at the waters. We are awaiting final funding on a water quality testing grant from Georgia Power Foundation. We plan on applying again, in conjunction with local governments, for the Georgia Outdoor Stewardship Program grant.
