Please see below for sampling results from last week on the Withlacoochee River. Monday (2/10) was the only day with results over health threshold. With additional rain, the County Health Departments plan to keep the advisory out and continue sampling this week. I touched base with Michael Mitchell, this health advisory has shifted to a local county level response and sampling is not being coordinated at the state level. They have asked for any additional information that people should be directed to DOH-Hamilton and DOH-Madison listed as contacts on the advisory and no longer to FDEP and FDOH state office in Tallahassee although they will continue to pass on information they receive.
