
Three Judges for Suwannee Riverkeeper Songwriting

Judge Tony Buzzella lives in Lake City, and was raised in Miami, FL. He studied under many great teachers, and he has performed with many great musicians over the years, including Frank Hubble, Charlie "Brown" Weatherbee, Rusty Hammerstrum, Leo Villar, Carlos Guzman, and the "Our Gang" Dixieland band during the 1960s and '70s. He has also performed with Pete Fountain, Bonnie Dawson, Freddie Palmer, Jerry Clower, Grandpa Jones, The Original Salt & Pepper Trio, The Gainesville Jazz Orchestra, Alfonso Levy, and many others.

Judge Anna Stange moved to Madison, FL, in 2019, after 25 years as a music teacher, performer, and educator in the Chicago area. Well known for her multicultural music programs, Anna performed at festivals, libraries, and community events, from Key West to Seldovia, Alaska. Mission: WWALS advocates for conservation and stewardship of the surface waters and groundwater of the Suwannee River Basin and Estuary, in south Georgia and north Florida, among them the Withlacoochee, Willacoochee, Alapaha, Little, Santa Fe, and Suwannee River watersheds, through education, awareness, environmental monitoring, and citizen activities.

Our Watershed: The 10,000-square-mile WWALS territory includes the Suwannee River from the Okefenokee Swamp to the Gulf of Mexico, plus the Suwannee River Estuary, and tributaries such as the Withlacoochee and Alapaha Rivers as far north as Cordele in Georgia, as well as parts of the Floridan Aquifer—the primary water source for drinking, agriculture, and industry for millions of Georgia and Florida residents.
