This is a rule development workshop to discuss and receive public input on the development of proposed amendments to portions of Chapters 62-550, 62-555, and 62-610, Florida Administrative Code (F.A.C.), and create a new Chapter 62-565, F.A.C. These amendments and new chapter will create a new set of rules for potable reuse. These changes will simplify and clarify existing rule language and establish requirements for potable reuse.
