Six Floridians at the Gates in the Okefenokee Swamp before paddling 250 miles of the entire Suwannee River in 2.5 days




Full Moon Paddles in Banks Lake NWR

- Mostly paid for by grants from GA-DNR.






Future Troupville Nature Park and River Camp

Suzanne Welander, co-author, Canoeing and Kayaking Georgia

Spoke about boating passage on creeks and rivers,



- and how that is impeded by the antique 1863 Georgia navigability law.
- Few shipped bales of cotton to market down the shoal-infested Little, Withlacoochee, Alapaha, or Suwannee Rivers.
- Nowadays, economic uses of the rivers include paddling, power boating, fishing, and swimming.
- The Georgia House held a study committee on navigability, but decided to do nothing.
- Maybe the Senate can take up the case of navigability and passage.
- That would help attract more people to recreate on our waterways,
- and it would help attract the sort of people who want to work in the kinds of clean industries local and state government are trying to bring here.
- The state could also fund more than one game warden for many counties, and do more to eradicate chronic wasting disease.

Rick Davis, chair of the River contamination Task Force of the dozen downstream Florida counties

Spoke about the more than \$160 million Valdosta has spent fixing its sewer system

He urged more water quality testing by Valdosta

Water Quality Testing and Reporting

So people will know when the rivers are clean

- Friday WWALS water quality report
- from our volunteer water quality results
- using Georgia Adopt-A-Stream methods,
- from results by Valdosta Utilities, and
- sometimes with results from Florida agencies.

Yet more water quality testing is needed

- to find sources of contamination,
- including upstream from Valdosta.

The State can fund water quality testing & reporting

Maybe expand *Know Your River* beyond Savannah and Ogeechee Rivers.

 The Senate can help stop trash at the source by passing something like SB 49 from 2024

"except for exempt items, **no persons** who are engaged as dealers in the sale at retail and who are subject to the collection of sales and use taxes under Part 2 of Article 1 of Chapter 8 of Title 48 **shall** distribute any bag made of plastic film or item made of extruded polystyrene foam."

Other states have done that, recently Colorado.


Sugar Creek Urban Greenway
